

## Official Rules

### 2017 Sauce Big Game Catering Giveaway

**THIS CONTEST IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES WHO ARE 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY.**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR CLAIM THE PRIZE. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

**Sauce LLC is the "Sponsor" of this contest.**

**1. SWEEPSTAKES PERIOD:** The Sauce Big Game Catering Giveaway ("Sweepstakes") begins at 12:01 AM Pacific Standard Time ("PST") on January 11, 2017 and ends at 11:59 PM PDT on January 23, 2017. ("Sweepstakes Period"). The Sweepstakes computer, as determined by Sponsor in its sole discretion, is the official time keeping device for the Sweepstakes.

**2. ELIGIBILITY:** The 2017 Sauce Big Game Catering Giveaway (the "Contest") is open to legal residents of the United States, 18 years of age or older at time of entry. Officers, directors, employees and agents of Sauce, LLC and its respective affiliated companies, agencies, and immediate families are not eligible. The Contest is void where prohibited.

**3. HOW TO ENTER:** There are three ways to enter the Sweepstakes:

A. **Instagram Posting Option:** Follow Sauce Pizza & Wine on Instagram (@SaucePizzaWine) and tag a friend between January 11<sup>th</sup> through January 23<sup>rd</sup>, 2017. For each friend you tag you'll be entered in the Catering Giveaway Sweepstakes.

B. **Current Sauce E-Family Database:** By being subscribed to Sauce E-Family, an entry is automatically entered for the Catering Giveaway Sweepstakes. In addition, by forwarding the Sauce Catering Giveaway email to a friend between January 11<sup>th</sup> through January 23<sup>rd</sup>, 2017, you'll receive an additional entry for each email that is forwarded in the Catering Giveaway Sweepstakes.

C. **Subscribe to Sauce E-Family Database:** Sign up for Sauce Pizza & Wine's Database to be entered in the Catering Giveaway Sweepstakes between January 11<sup>th</sup> through January 23<sup>rd</sup>, 2017.

Anonymous Entries will not be eligible. Entry must not contain material that is inappropriate, indecent, obscene, hateful, tortuous, defamatory, slanderous or libelous. The Entry must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age. There is no limit on the number of unique Entries you may enter. We are not responsible for late, lost, misdirected, or invalid Entries.

Once you submit your Entry, you will be officially entered into the Contest. Entries cannot be revised or altered once submitted. Once submitted, all submitted components become the property of the Sponsor. Automated means of entry and entries by any means which subvert the entry process are prohibited and all such entries will be void.

**PRIZE AND THE VALUE OF THE PRIZE:** Four (4) Grand Prizes: Grand Prize winners will receive a \$150.00 catering package. The approximate retail value (ARV) of the Grand Prize is

\$150.00. Any difference between the stated ARV and the actual value, if any, will not be awarded.

The prize may not be transferred, assigned or changed except at the sole discretion of Sponsor. Sponsor reserves the right to substitute the prize in whole or in part with other prizes of comparable or greater value if the intended prize is not available for any reason as determined by the Sponsor in its sole discretion. The winner of any prize valued over \$599.99 will be required to provide their Social Security numbers and appropriate tax documentation for tax reporting purposes. Sponsor will file, where required, an IRS Form 1099 with the Internal Revenue Service for the fair market value of any prize.

#### **4. SELECTION OF WINNERS/PRIZES:**

On or about January 27, 2017 Sponsor will randomly select four (4) winners in a random drawing consisting of all qualified entries during the Sweepstakes Period. The drawing will be conducted by Sponsor or its designee, the judges of the Sweepstakes, whose decisions are final and binding on all matters related to the Sweepstakes. The four (4) winners will each win a \$150 Sauce Pizza & Wine Catering package valid at all locations. Three (3) winners will be selected at random from entry via email database subscription and one (1) winner will be selected at random from entry via Instagram tag-a-friend post. This prize cannot be combined with any other offers or discounts. The winners will be selected no later than January 27, 2017 and will be contacted by Sponsor through the winner's email, Instagram, or telephone. The winner will be required to reply to the email (or direct message) within 5 (five) days to claim prize. Redemption date of prize must be before March 31, 2017. If the winner is unwilling, fails to reply, or is unable to use the prize by March 31, 2017, the Provisional winner will be disqualified and a substitute Provisional winner will be selected from among the remaining entrant using the process set forth above.

**5. PRIZE DETAILS AND RESTRICTIONS:** The prize is non-transferable. Federal, state and local taxes, if any, associated with the acceptance of the prize are the sole responsibility of the winner and its designated charity.
