

Official Rules

The 2019 Big Game Catering Giveaway

(THIS CONTEST IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES WHO ARE 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR CLAIM THE PRIZE. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

Sauce LLC is the "Sponsor" of this contest.

SWEEPSTAKES PERIOD: The Sauce 2019 Big Game Catering Giveaway ("Sweepstakes") begins at 12:01 AM Pacific Standard Time ("PST") on January 16th 2019 and ends at 11:59 PM PST on February 3rd, 2019. ("Sweepstakes Period"). The Sweepstakes computer, as determined by Sponsor in its sole discretion, is the official time keeping device for the Sweepstakes.

ELIGIBILITY: The 2019 Big Game Catering Giveaway (the "Contest") is open to legal residents of the United States, 18 years of age or older at time of entry. Officers, directors, employees and agents of Sauce, LLC and its respective affiliated companies, agencies, and immediate families are not eligible. The Contest is void where prohibited.

HOW TO ENTER: There are two ways to enter the Sweepstakes:

A. Catering purchase: Place and receive an order for a Sauce Pizza & Wine catering pack between January 16th and February 3rd, 2019. Catering purchase must be made through online inquiry at <http://www.saucepizzaandwine.com/catering/>. In-store or phone-in catering purchases will not be considered as an entry into the Sweepstakes.

B. Send in an inquiry during the promo period for more info on Sauce catering via the following form: <http://www.saucepizzaandwine.com/catering/>.

Once you submit your Entry, you will be officially entered into the Contest. Entries cannot be revised or altered once submitted. Once submitted, all submitted components become the property of the Sponsor. Automated means of entry and entries by any means which subvert the entry process are prohibited and all such entries will be void.

PRIZE AND THE VALUE OF THE PRIZE: One (1) Grand Prize: Grand Prize winner will receive a \$200.00 gift card to Sauce Pizza & Wine. The approximate retail value (ARV) of the Grand Prize is \$200.00. Any difference between the stated ARV and the actual value, if any, will not be awarded.

SELECTION OF WINNERS/PRIZES: On or about February 4th 2019. Sponsor will randomly select winners in a random drawing consisting of all qualified entries during the Sweepstakes Period. The drawing will be conducted by Sponsor or its designee, the judges of the Sweepstakes, whose decisions are final and binding on all matters related to the Sweepstakes. The winner will win a \$200 Sauce Pizza & Wine gift card. This prize cannot be combined with any other offers or discounts. The winner will be selected no later than February 5th 2019 and will be contacted by Sponsor through the winner's email or telephone. The winners will be required to reply to the email (or direct message) within 3 (three) days to claim prize. If a winner is unwilling, fails to reply, within the three (3) days, the Provisional winner will be disqualified and a substitute Provisional winner will be selected from among the remaining entrant using the process set forth above.
